Consumer Competition Terms and Conditions/Rules

If you already follow Spekko on the Meta platforms (Facebook and Instagram), you will have to click on the Spekko 7 Days 7 Ways competition promoted post.
- b. Once you have clicked on the Spekko 7 Days 7 Days competition advert or post, you will be directed to a Spekko 7 Days 7 Days competition lead form.
 - c. You must complete the full lead form to qualify for a successful entry.

- d. One (1) complete lead form is one (1) entry
- e.
